Terms of Use for NOCKBIKE Mountain Biking Routes

1. These terms of use govern the use of the **NOCKBIKE mountain biking routes** (hereinafter referred to as "mountain biking routes"). The mountain biking network of the **Region Millstätter See - Bad Kleinkirchheim - Nockberge Tourismus GmbH** (hereinafter referred to as "Region Millstätter See - Bad Kleinkirchheim - Nockberge Tourismus GmbH") includes both the **NOCKBIKE mountain bike trails** (hereinafter referred to as "trails") and the **NOCKBIKE mountain bike tours** (hereinafter referred to as "tours"). The use of the mountain biking routes is only permitted in compliance with the following terms of use. Should the user violate one or more of these terms of use, the Region Millstätter See - Bad Kleinkirchheim - Nockberge Tourismus GmbH, its authorized personnel, or other authorized service providers are entitled at any time to expel the user from the mountain biking trail.
2. The trails and tours are each marked accordingly. Further information on the mountain bike trail network is available on our website www.nockbike.at.
3. The mountain bike trails may only be used during the designated operating hours. Outside these times, the trails are closed, and riding on them is not permitted. The respective operating hours are posted at the start of each mountain bike trail and can also be accessed at www.nockbike.at/trails. Even during operating hours, trails or parts thereof may be closed and must not be used in such cases.
4. The trails are color-coded according to their level of difficulty and are categorized as follows:
 - Green: Very easy
 - Blue: Easy
 - Red: Intermediate
 - Black: Difficult
5. A detailed description of these difficulty levels is posted at the start of each trail and can also be viewed at www.nockbike.at/trailticket-agbs. Before riding a trail, the user is obliged to carefully read the description of the difficulty levels and to select only a trail that corresponds to their ability, experience, and equipment. It is generally

recommended to start with the easiest difficulty level and to inspect each trail in advance.

6. Bringing pets on the mountain bike trails is prohibited. Children and adolescents under the age of 16 may only use the mountain bike trails when accompanied by an adult, who is responsible for ensuring that the child or adolescent uses only those trails whose difficulty levels are manageable for them based on age, individual ability, and equipment. The child or adolescent must be carefully instructed by the adult before riding. Parents are liable for their children.
7. Riding on the mountain bike trails is only permitted with a helmet and a bicycle suitable for safely navigating the trails. The use of additional protective gear is strongly recommended.
8. Before each ride, the bicycle and equipment must be checked.
9. The mountain bike trails may only be used in a physical and health condition that allows the trail to be navigated safely. Riding under the influence of alcohol or drugs is prohibited.
10. The mountain bike trails are marked either as separate routes or as shared trails. Shared trails are multi-use and may also be used by hikers and/or motor vehicles. Hikers have priority.
11. When riding on the mountain bike trail, the user must strictly adhere to the designated direction of travel, unless the trail is explicitly open to two-way traffic. Riding against the direction of travel is strictly prohibited.
12. Warning, information, mandatory, or prohibition signs on the trail must be observed. Any instructions given by persons working on or near the trail must be followed.
13. Use of the mountain bike trails is at the user's own risk.
14. In general, the use of the mountain bike trails is prohibited during heavy rain or storm events. The user acknowledges that they are in alpine terrain and therefore may be exposed at any time to alpine hazards such as rockfall, landslides, erosion, or fallen trees. They must adjust both their equipment and their behavior to these hazardous

conditions.

15. On all mountain bike trails, including trails, users must expect the presence of people, grazing livestock, wildlife, vehicles, rocks, fallen trees, potholes, or other obstacles at all times. The user must therefore always ride at a controlled speed and with half visibility so that they are able to stop safely at any time should obstacles appear or approach. The user acknowledges that no regular inspection of the mountain bike trails takes place.
16. At unclear or dangerous locations, speed must be reduced. In the case of sudden or unexpected obstacles, the rider must dismount and push the bicycle past the obstacle.
17. The mountain bike trails must be used with care. Riding must be conducted in such a way that no deep tracks are left.
18. Only the designated, marked trail may be used. Leaving the marked mountain bike trail is not permitted, except for access to and return from the trail via public roads or approved paths.
19. Forest roads are operational areas and workplaces. Users must therefore expect work machinery, timber on the road, potholes, grazing livestock, and motor vehicle traffic. Particular attention must be paid to motor vehicles and pedestrians. Temporary closures imposed by the landowner due to forestry work or hunting must be observed.
20. The Road Traffic Regulations apply on all mountain bike trails.
21. In the forest, camping, staying overnight after dark, lighting fires, disturbing wildlife, and entering forest plantations under 3 meters in height are strictly prohibited by law.

 2. Die Mountainbikestrecken sind schonend zu benützen. Es ist so zu fahren, dass keine tiefen Spuren hinterlassen werden.
 3. Zu benutzen ist ausschließlich die freigegebene, markierte Strecke. Das Verlassen der markierten Mountainbikestrecke ist daher – ausgenommen die Zu- und Abfahrt zur oder von der Mountainbikestrecke über öffentliche Straßen oder freigegebene Wege – nicht zulässig.

4. Forststraßen sind Betriebsflächen und Arbeitsplatz. Rechnen Sie daher mit Arbeitsmaschinen, Holz oder Schlaglöchern auf der Fahrbahn, Weidevieh und Kraftfahrzeugverkehr. Auf Kraftfahrzeuge und Fußgänger ist besonders zu achten. Allfällige vom Grundeigentümer aufgrund der Waldarbeit oder des Jagdbetriebes verhängte befristete Sperren sind zu beachten.
5. Es gilt auf den Mountainbikestrecken generell die Straßenverkehrsordnung.
6. Im Wald sind insbesondere das Zelten, das Lagern bei Dunkelheit, das Feuermachen, die Beunruhigung von Wild und das Betreten von Forstkulturen unter 3 m Baumhöhe gesetzlich verboten.
